1. RWC Instructor completes Probationary Examiner Application form and sends to SLSNZ Member Education.
2. Pre-requisites checked.
3. Club and Regional endorsement is sought.
4. Application sent to National RWC Chief Examiner and National Education Manager.
5. Area, regional and national examiner needs analysis completed by RWC Chief Examiner, Regional Lifesaving Manager and National Education Manager.
6. If approved, entered in to PAM as 'Probationary Examiner' before being eligible to attend first exam as a probationary examiner.  
The examiner workbook will then be distributed by SLSNZ to the probationary examiner to complete (if required).
